

# Practice Tips From PLF

#### Getting Started

almost immediately no matter how small - begin anywhere - just do something. It can be something as simple as making a file folder and putting a note in it. Even if the deadline for the project is far off, it is helpful to do something on it.

Each entry should have enough detail to not only justify the time claimed, but also to show the value received. The more descriptive your billing entries, the less likely the client is to question or balk at the time incurred.

Over and above each individual billing entry, the entries on an invoice can also serve, collectively, as a monthly progress report. A client should always have a pretty good idea what is happening in litigation by virtue of the invoices alone. Ideally, your invoices will show concrete progress towards a discrete goal, such as resolution through trial or settlement.

### Secure Storage of Files in the Cloud

LogMeIn's Cubby (www.cubby.com) is a cloud storage service with native applications for Windows, Mac, Android, and iOS.

Cubby's DirectSync technology enables you to cloud-enable one or more folders on your computer. These folders continue to function like regular folders except that you can access and modify the documents in these folders on your other devices using the Cubby apps. Any changes you make sync back to your original folder and across all your devices. Versioning enables you to keep all prior versions of a document.

LogMeIn claims that Cubby offers superior security than Box, Dropbox, Google Drive, and others because it encrypts your documents in addition to providing a secure connection to them. Cubby Pro and Cubby Enterprise offer even more security via Cubby Locks. When you apply a Cubby Lock to a folder, you must enter a second folder-specific password to access its documents.

## New 2013 Notary Guide now available!

The New 2013 Notary Guide is now available on the Secretary of State, Corporation Division website. There have been several updates to the guide and we encourage you to take a moment to view the new guide.

Be sure to view our list of <u>Live Seminar Locations</u>; we add new locations monthly. We encourage you to attend a live seminar to remain current on notary laws and rules, to ask questions and participate in discussions.

The 2013 Oregon Legislature adopted the Revised Uniform Law on Notarial Acts, completely replacing the old notarial statutes with modern and standard language. Please see our announcement page Notary Law Changes to see a copy of the new law and proposed rules. To match the updated laws, the Secretary of State has modernized its method of commissioning Oregon notaries public, too. The new system will be in place beginning September 3, 2013.

#### **Keep Your Dropbox Files Safe**

Lots of lawyers are using Dropbox to store files online and access them from multiple devices. According to the 2013 ABA Legal Technology Survey Report, it is not only the most popular cloud storage platform among lawyers, but also the most popular cloud-based application of any kind among lawyers. Even so, many lawyers remain concerned about the security of the files they load into Dropbox.

A new application released last week, Safebox (<a href="www.safeboxapp.com">www.safeboxapp.com</a>), enables you to encrypt your files before you send them to Dropbox, so that they do not leave your computer until they are protected with what the company promises is military-grade security. (It uses AES-256, the advanced encryption standard with a 256-bit key.) Once the encrypted file is added to Dropbox, you can retrieve it from any other computer you use, provided you have also installed Safebox there. The free download allows you to store five encrypted files and you can purchase

That six week float on the credit card is one you should be capitalizing upon to keep your cash flow steady, your receivables almost non-existent, and all that time you now save on billing and collection should be going towards working on your clients' cases and marketing for more business.

## **Interesting Tidbit Regarding Oregon Motto**

Oregon State Motto Timeline 1854 "She Flies With Her Own Wings" 1957 "The Union" 1987 "She Flies With Her Own Wings"

"She Flies with Her Own Wings" was adopted by the 1987 Legislature as the state motto. The phrase was written by Judge Jessie Quinn Thornton and translated into Latin for the territorial seal in 1854. "Alis Volat Propiis" is the Latin translation. Chapter 848, 1987 Oregon Laws, most clearly describes the events that led to the choice for the state's motto in 1854.

"Relating to the state motto; amending ORS 186.040.

Whereas the spring of 1843 found the Oregon County politically unorganized and its inhabitants in disagreement over whether their future lay beneath the wing of Britain or that of the United States; and

Whereas on the second day of May in that year of 1843, the settlers of the Oregon

Country gathered at the settlement of Champoeg and voted, by division of those present, to form a provisional government dependent upon neither Britain nor the United States, but dependent only upon the inherent political authority of its own people; and

Whereas the Oregon Territorial Legislature, on January 18, 1854, recognized this seminal event in the history of the Oregon Country by adopting as the motto of the Oregon Territory the Latin phrase, "Alis Volat Propiis," which, in English, means "She flies with her own wings"; and

Whereas the motto appropriately reflected the independent character of the Oregon pioneer settlers who established their own government ..."

In 1957, the motto was changed to "The Union." According to former Senate historian Cecil Edwards, "The Union" goes back to earlier years in Oregon when citizens "were torn over the issue of slavery." 1

Senate historian Cecil Edwards, Secretary of State Barbara Roberts and former state Senate President Jason Boe were the sponsors for the 1987 Senate Bill 1036 which proposed changing the motto back to "She Flies With Her Own Wings." Supporters of the bill felt that "She Flies With Her Own Wings" reflected Oregon's tradition of independence and innovation. Sen. Frank Roberts said that Oregon was the first in many areas including the bottle bill and the public beach access bill. In addition Oregon was the first in some national issues among which were providing for the recall of public officials in 1908, statewide voter registration in 1899 and the first celebration of Labor Day.
